The vendor has to provide for the test execution:

- EMVCo Level 1 Contactless DTE for analog/digital
- Two (2) operational samples plus charger (original)
- · Valid EMVCo ICS for COTS

EAP interoperability will be tested with EMVCo test applet. Vendor has to proof licence for the applet.



LEVEL 2 - SOFTPOS TESTING FOR PAYMENT SYSTEMS
